Type A City (Local Gov't Code, Section 22.032) Mayor – Residence – 1 yr in state before filing deadline; 1 yr in city prior to election day. Age 18 and must be a registered voter in territory elected from by the filing deadline. Councilmember – City Council – Residence – 1 yr in state prior to filing deadline; 6 months in the city prior to filing deadline. Age 18 Must be a registered voter in territory elected from by the filing deadline. All candidates must swear and affirm the following: <ol style="list-style-type: none"> 1) They have not been finally convicted of a felony for which they have not been pardoned or had their full rights of citizenship restored by other official pardon. 2) They have not been determined by a final judgement of a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote. 3) They are aware of the nepotism law, Chapter 573, Gov't Code.
